Thank you, Governor Newsom, Legislative Authors, and our Supporters



We extend a heartfelt thank you to Governor Gavin Newsom for signing four of our CCRC-sponsored bills into law. We would also like to thank the incredible legislative authors we worked with and our fellow cosponsors and supporters for their hard work and dedication in making this victory possible. We are deeply grateful for your partnership in advancing policies that will positively impact the lives of Californians for years to come. This achievement is a testament to the power of collaboration, and we look forward to continuing this vital work together.

Here is a refresher on the new laws:



Assemblymember Reves



This bill removes the 10 year limit on the Child Development Associate Teacher Permit holder. It allows unlimited renewal every 5 years (similar to the other permit levels) and retains well qualified, diverse and experienced teachers in early care and education (ECE) settings. This is especially crucial at a time when the field is faced with staffing shortages that result in "dark classrooms." Stability is critical for the future of the field. ECE workforce policy levers such as this coupled with California's child care rate reform to support wage increases can help recruit, retain, and reclaim this workforce.

Co-Sponsored with California Head Start Association, Kidango, EveryChildCA, California County of Superintendents, Los Angeles County Office of Education, Santa Clara Office of Education



This law will address gaps in California's systems of care coordination by allowing alternative payment agencies to use their administrative funds to pay for the cost associated with providing parents enhanced navigation and referral services. These referrals to a medical professional will enable access to developmental screening services for children aged 0-5.

AB 2343 (Schiavo) – CalWORKs: Child Care Access for Parents & Children Experiencing Homelessness or Domestic Violence (Read More & Watch Now) – Signed into Law on September 29, 2024

This bill will allow Alternative Payment agencies administering CalWORKs Stage 1 and Stage 2 to use their administrative funds for support services to provide families experiencing homelessness or escaping domestic abuse access to stable child care.

AB 51 (Bonta) – Early Child Care Education - California State Preschool - Signed into Law on September 26, 2024

This bill directs the California Department of Education (CDE) to develop early learning resources, guidance, and technical assistance to prospective <u>California State Preschool Programs (CSPP)</u> contractors available at the <u>California Department of Education</u>. The end goal is to provide aspiring CSPP contractors an equitable opportunity to access Title 5 workforce training and administrative systems through educational outreach efforts to what is sometimes a complex system to navigate independently.

House Representatives Bill: H.R. 8798

H.R. 8798 titled <u>Strengthening Families with Community Based Prevention Services</u> strives to define and clarify the role of family resource centers at the federal level. This bill passed the U.S. House of Representatives led by bipartisan support and is to be included with H.R. 9076 Package. <u>H.R. 9076</u>, <u>Title IV B Reauthorization: Supporting Children's & Families Act</u> passed the House Floor with 405 yeas to 10 nays to strengthen community support. Should the bill pass the Senate and be signed into law by the President. Funds can be allocated for <u>four</u> primary broad core service areas:

- Provide family support services
- Family preservation services
- Family reunification services
- · Adoption promotion and support services

The Universal PreKindergarten (UPK) Partnership Guidebook is a consortium of six statewide organizations invested in the successful implementation of the full mixed delivery system for 3- and 4-year-olds with funding from Heising-Simons Foundation, Our aim is to create a repository of shared resources, best practice guides and toolkits, and practical tools curated from the field to support family serving organizations, community based organizations, and local education agencies that participate in UPK supported by the UPK Guidebook.
